Note: The Director, Government. Dental College & Research Institute, Ballari reserves the right of cancelling the Notification/ Appointment Process without assigning any reasons.

1. Last date for receipt of applications:

Filled applications should be submitted along with 2 sets of Xerox documents duly attested by gazetted officer to the Office of the Director, Govt. Dental College & Research Institute, Ballari on or before **16.04.2016, 05:30 P.M.** The candidates who are appearing for the interview must bring original documents in person.

2. **Age Limit:**

Maximum age of 40 years for G.M candidates, 43 years for O.B.C candidates, and 45 years for SC/ST Category-1 candidates, as on the last date prescribed for receipt of applications.

3. In respect of Ex-Serviceman the maximum age limit is relaxed by number of years of service in defence. And plus three years and in respect of Physically Handicapped persons and widows, by 10 years. For In-Service candidates the upper age limit may be relaxed by number of years of service in State Government/Central Government/Public Sectors, subject to maximum of 10 years.

4. **Age limit for the posts of Dental Hygienst and Dental Mechanic candidates is as follows:**

1. 33 Years for GM.
2. 36 Years for all reserved categories &
3. 38 Years for SC/ST.

5. Such of those candidates who have not taken kannada as a 1st & 2nd Language for 100 marks shall pass departmental kannada language examination within the probationary period of 02 years. [For regular appointments only]

6. **Reservation for Hyderabad Karnataka region:**

The candidates belonging to Hyderabad Karnataka region shall be regarded as local persons if he/she produces eligibility certificate issued by jurisdictional Assistant Commissioner, Revenue sub division as specified in the Govt. Order No.DPAR 52 HKC 2015, dated: 01/10/2015.

7. **Method of Selection (For Teaching faculty only)**

Candidate will be selected through the process of interview. The method of recruitment shall be on the basis of merit, the merit list shall be prepared on the basis of percentage of marks obtained in the qualifying examination, marks obtained in fixed parameters and the marks obtained in the interview conducted by the selection committee. The Maximum marks in the Interview shall be fifteen (15). If two candidates secure a equal percentage of marks, then the candidate older in age may be selected.

8. **ELIGIBILITY CONDITIONS**

1. Should be a citizen of India.
2. No man who has more than one wife living and no woman who has married a man already having another wife, shall not be eligible for appointment.
3. Candidate should be physically and mentally fit to discharge the duties.
4. No person is eligible for appointment who is convicted in any criminal case, touching moral turpitude.
5. Candidates who are employed in the Govt. or Govt. organizations shall submit their applications through the Appointing authorities under whom they are working.

9. **CERTIFICATE FOR CASTE RESERVATION:**

Candidates claiming any reservation shall produce caste certificates issued by the competent authority in the prescribed format.

10. **PHYSICALLY HANDICAPPED:** Candidates shall produce certificate of disability from the appropriate authority as per rules.

11. The candidate claiming previous experience should compulsorily produce the original salary certificate experience certificate, attendance extract & copy of form no. 16 issued by Director/Principal of the concerned Dental College/Institution.

12. **Application Fee:**

Candidates should pay application processing fees of Rs.1000/- and candidates belonging to SC,ST & CAT-I shall pay a fee of Rs.500/- in the form of DD drawn in favour of Director, GDCRI, Ballari, payable at Ballari.


13. Candidates while Submitting the Applications shall furnish the copies of following documents duly attested by Gazetted Officer:

- A. Date of Birth certificate
- B. SSLC or equivalent Examination Marks Cards
- C. II PUC or equivalent Examination Marks Cards
- D. BDS or equivalent Degree Marks Cards with Convocation certificate
- E. MDS or equivalent Degree Marks Cards with Convocation certificate
- F. KSDC valid registration certificate
- G. Valid Caste and Income certificate in prescribed Proforma issued by the competent authority
- H. Disability certificate in respect of PH candidates

- I. Any other applicable certificates
 - J. Copies of the supporting documents claiming the reservations
 - h. SSLC/PUC-II & Dipoloma/Certified Course in Dental Hygenist from a recognized institution.
 - i. SSLC/PUC-II & Dipoloma/Certified Course in Dental Technicians from a recognized institution.
