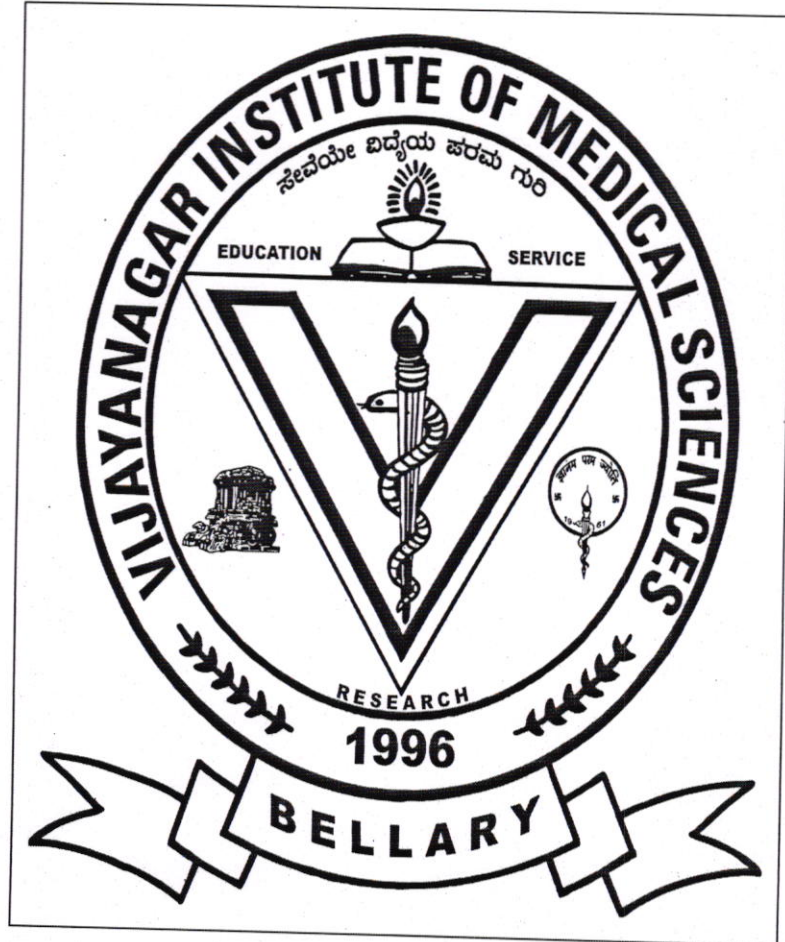

**Candidates must report in Principal office at Vijayanagara Institute of Medical Sciences, Ballari (VIMS) for POST GRADUATE DEGREE / DIPLOMA admission on or before date indicated on their selection letter issued by NEET (AIQ & SQ) before 10-30 A.M.**


1. The admission process is likely to take two days.
2. The candidates are instructed to keep Xerox copies of all original documents submitted to office of the VIMS, Ballari at the time of admission and preserved for future use until they are returned from Rajiv Gandhi University of Health Sciences, Bengaluru after getting approved.
